SUMMARY: The Department of Homeland Security (DHS), U.S. Citizenship  
and Immigration Services (USCIS) invites the general public and other

Federal agencies to comment upon this proposed extension of a currently approved collection of information. In accordance with the Paperwork Reduction Act (PRA) of 1995, the information collection notice is published in the Federal Register to obtain comments regarding the nature of the information collection, the categories of respondents, the estimated burden (i.e., the time, effort, and resources used by the respondents to respond), the estimated cost to the respondent, and the actual information collection instruments.

DATES: Comments are encouraged and will be accepted for 60 days until February 19, 2013.

- (2) Evaluate the accuracy of the agency's estimate of the burden of the proposed collection of information, including the validity of the methodology and assumptions used;
- (3) Enhance the quality, utility, and clarity of the information to be collected; and
- (4) Minimize the burden of the collection of information on those who are to respond, including through the use of appropriate automated, electronic, mechanical, or other technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses.

(2) Title of the Form/Collection: Application for Advance Permission to Enter as Nonimmigrant [Pursuant to Section 212(d)(3)(A(ii) of the INA].

(3) Agency form number, if any, and the applicable component of the DHS sponsoring the collection: Form I-192; USCIS.

(4) Affected public who will be asked or required to respond, as well as a brief abstract: Primary: Individuals or households.

(5) An estimate of the total number of respondents and the amount of time estimated for an average respondent to respond: 10,448 responses at 0.5 hours (30 minutes) per response.

(6) An estimate of the total public burden (in hours) associated with the collection: 5,224 annual burden hours.
