WASHINGTON,D.C. (WUSA) - More videos showing GSA officials mocking the government's easy cash have surfaced as a White House source says at least eight officials are now in trouble.

"This type of waste and abuse is outrageous," said Congressman Jeff Denham (R-Ca.), Chairman of the Subcommittee overseeing the General Services Administration. "The Committee is prepared to request subpoenas, if necessary."

An source within the Obama Administration who asked to not to be identified says the eight officials have either resigned, been fired, or placed on administrative leave.

GSA Administrator Martha Johnson resigned last week.

The videos and employment actions follow an Inspector General investigation into a lavish \$820,000 Las Vegas convention and party thrown by the General Services Administration.
