Thank you for your service. VA is aware that exposure to chemicals, primarily PCB, may have occurred in Anniston, Alabama, nearby Fort McClellan. The Agency for Toxic Substances and Disease Registry (ATSDR) is sponsoring studies on potential health effects. Information is available at http://www.atsdr.cdc.gov.

VA is also aware that Fort McClellan was the site of outdoor training use of small quantities of chemical agents (mainly mustard agent). VA is monitoring these issues. You are encouraged to submit a compensation claim for any health condition you have that you believe is related to your service at Fort McClellan.

We also are concerned about your experience as a woman Veteran using Transportation and other services. We will have a member of our Women's Health Services contact you directly to discuss these issues. We encourage Veterans to discuss their concerns with the Women Veteran Program Manager at their local facility.
