| 1  | Registering entity legal name                                     | Legal name of either for the applicable manufacturer or applicable group purchasing organization.  |
| 2  | Doing business as (DBA) name                                      | The DBA name of the applicable manufacturer or applicable group purchasing organization, meaning the trade name, or fictitious business name, under which the business or operation is conducted and presented to the world and not the legal name of the applicable manufacturer or applicable group purchasing organization.   |
| 3  | Consolidated report indicator                                     | Indicator showing whether the applicable manufacturer or applicable group purchasing organization registering intends to be part of a consolidated report.   |
| 4  | Parent company name   | The name of parent company if the applicable manufacturer or applicable group purchasing organization registering is a subsidiary of a parent company.   |
| 5  | URL of parent company   | The uniform resource locator (URL) or web address, which is a specific character string that constitutes a reference to a resource for the applicable manufacturer or applicable group purchasing organization. If the entity registering is a subsidiary to a parent company, provide the URL of the parent company.  |
| 6  | Registering entity business type                                  | Applicable manufacturers and applicable group purchasing organizations are required to identify the type of applicable manufacturer or applicable group purchasing organization.   |
| 7  | Registering entity type of ownership                              | Applicable manufacturers and applicable group purchasing organizations are required to select a corresponding type of ownership from the following list: (1) sole proprietorship, (2) partnership, (3) corporation, or (4) other. Applicable manufacturers and applicable group purchasing organizations indicated other will be required to describe their type of ownership.   |
| 8  | Tax Identifier Number (TIN): EIN - Employer Identification Number | The Employer Identification Number (EIN), also known as a federal tax identification number (TIN) used to identify a business entity (an applicable manufacturer or applicable group purchasing organization).   |
| 9  | FDA Establishment Identifier (FEI)                                | <b>FDA Establishment Identifier (FEI)</b> or the unique identifier designated by FDA to assign, monitor, and track inspections of FDA regulated entities. These establishments are required to register annually with the FDA. <a href="http://www.access.fda.gov/">http://www.access.fda.gov/</a><br><br>An establishment identifier (or registration number) is assigned to all establishments or facilities registered with the FDA, including entities which manufacture, prepare, propagate, compound or process drugs that are commercially distributed in the U.S. or offered for import to the U.S. and that are involved in the production and distribution of medical devices intended for use in the United States. |
| 10   | DUN & Bradstreet (D&B) D-U-N-S® Number                            | A unique nine digit identification number for each physical location of a business provided by D&B.  |
| 11   | Registering entity business Address                               | The primary business address (Number and Street (or PO Box), City, State, and 9-digit Zip Code) of the applicable manufacturer or applicable group purchasing organization. For international addresses, also provide the Province, Country and International Postal Code, if applicable.  |

| 14   | Authorized Official Name   | The name for an individual (Authorized Official) of the applicable manufacturer or applicable group purchasing organization, who is an officer of the entity and may submit or attest to data on behalf of the entity and register the entity or approve the Registrant(s).  |
| 15   | Verify Authorized Official's relationship with applicable manufacturer or applicable group purchasing organization | Provide information to verify the Authorized Official's relationship with the applicable manufacturer or applicable group purchasing organization. This is an optional field, which will assist in verifying the Authorized Official has authority to register the entity, nominate and approve additional individuals to work on behalf of the applicable manufacturer or applicable group purchasing organization. |
| 16   | Authorized Official Job Title  | The job title for an individual (Authorized Official) of the applicable manufacturer or applicable group purchasing organization, who is an officer of the entity and may submit or attest to data on behalf of the entity and register the entity or approve the Registrant(s).   |
| 17   | Authorized Official Phone Number   | The phone number for an individual (Authorized Official) of the applicable manufacturer or applicable group purchasing organization, who is an officer of the entity and may submit or attest to data on behalf of the entity and register the entity or approve the Registrant(s).  |
| 18   | Authorized Official Email  | The email address for an individual (Authorized Official) of the applicable manufacturer or applicable group purchasing organization, who is an officer of the entity and may submit or attest to data on behalf of the entity and register the entity or approve the Registrant(s).   |
| 19   | Authorized Official Business Address   | The primary business address (Number and Street (or PO Box), City, State, and 9-digit Zip Code) of the individual, who is an officer of the entity and may submit or attest to data on behalf of the entity and register the entity or approve the Registrant(s). | 21   | Entity Authorized Representative Name  | Legal name (first, middle, last, suffix) of an individual authorized by the entity Authorized Official to access, review, and submit data on behalf of the entity. Applicable manufacturers and applicable group purchasing organizations have the opportunity to identify more than one authorized representative. Each authorized representative is designated as an officer, submitter, or attester.              |
| 22   | Entity Authorized Representative Job Title   | The official title of the job or position held by the individual or employee of the entity authorized by the entity Authorized Official to access, review, and submit data on behalf of the entity.  |
| 23   | Entity Authorized Representative Email Address   | The primary business email address of an individual authorized by the entity Authorized Official to access, review, and submit data on behalf of the entity.   |
