Dear Mr. Hodapp:

The Bureau of Economic Analysis (BEA) strongly supports the continued collection of data by the Railroad Retirement Board on the Railroad Service and Compensation Reports. These forms are our main data source for key components of BEA's economic statistics.

BEA uses data from these forms in the national income and product, input-output (I-O), and regional accounts. Data from forms BA-3a (Annual Report of Creditable Compensation), and BA-4 (Report of Creditable Compensation Adjustments) are used to prepare national estimates of railroad industry employment, wages and salaries, retirement benefits, and unemployment insurance benefits. The resulting estimates of railroad industry compensation are also used in the estimates of gross domestic product by industry and in the annual I-O accounts. Data from forms BA-3a, BA-4, and the BA-6a (Address Report) are used to prepare estimates of the wages and salaries, employer contributions for employee pension and insurance funds, and personal contributions for government social insurance components of State and county personal income. A list of items used is attached.

Please keep BEA informed concerning any modifications to this form. We are particularly interested in any modifications proposed during the forms approval process that would substantially affect our use of these data.
