The Bureau of Economic Analysis (BEA) strongly supports the continued collection of data on Form SHLA/SHL. The data collected on these forms are crucial to key components of BEA's economic statistics.

Annual and benchmark reports on foreign residents' holdings of U.S. securities are used directly in compiling statistics for BEA's International Investment Position (IIP). Specifically, these reports contribute to statistics on several lines of IIP Table 1 and Table 2, including lines 29, 30, 33, and 36-39 (U.S. Treasury securities and U.S. securities other than U.S. Treasury securities).

In addition, these reports are inputs for quarterly statistics of transactions and for annual revisions of those statistics in BEA's International Transactions Accounts (ITAs). Specifically, these reports contribute to lines 58, 59, 62, 65, and 66 (U.S. Treasury securities and U.S. securities other than U.S. Treasury securities), line 32 (Other private payments), and line 33 (U.S. government payments). These reports also contribute to statistics in Sections B and C of ITA Table 8a. Items used by BEA are listed in the attachment below.

Please keep BEA informed about any modifications to these forms. We are particularly interested in any modifications proposed during the forms' approval process that would substantially affect our use of these data.
