Cardinal Health Nuclear Pharmacy Services acts as both a shipper and carrier. We have the ability to assist emergency response organizations (law enforcement, hazmat, fire departments) with radiation safety concerns.

Locations

Cardinal Health Nuclear Pharmacy Services maintains a corporate home office in Dublin, Oh. Currently, we operate a nationwide footprint of nearly 140 nuclear pharmacies and 37 PET biomarker manufacturing facilities within the United States. Our facilities are centralized to service multiple customers to deliver patient-specific doses to 95% of hospitals within 3 hours.

Capabilities

We act as both an offeror and interstate carrier of hazardous material. More specifically, the cargo offered and carried is Class 7 Radioactive White–I, Radioactive Yellow–II, Radioactive Yellow–III hazardous material. To service our customers, Cardinal Health Nuclear Pharmacy Services operates a fleet of over 1,300 vehicles and 1,700 drivers. Recently, we have instituted electronic web-ordering systems, digital invoicing, route optimization, and proof-of-delivery systems. These systems give us "real time" visibility to shipments and are tracked via the internet and GPS.
