Dear Colleagues,

As InterAction continues to respond to USAID's proposed Partner Vetting System (PVS), we're hoping to gather concrete examples of how the system will negatively affect the work of our member organizations. We'd like examples related to both the administrative burden (e.g. - costs associated with gathering the information; resources that would be diverted from other programs; number of employees subject to vetting; vagueness of the regulation; etc.) and some of the anticipated impacts on your field programs. For example, one of our humanitarian organizations was able to respond very quickly to this summer's floods in Pakistan in a way that would likely have not been possible if subjected to the PVS. These examples will inform our conversations with policymakers here in Washington, both at USAID and in the Congress.

Second, it has come to our attention that the data collection form for the PVS is not available yet, but that there may be a waiting list for organizations who would like to see it as soon as it is.
