Dear Mr. Foldi,

Let me clarify that we are not making any changes to the information collection, but ratherare giving the public an opportunity to comment on the proposed extension of previously approved OMB information collection, as required by the Paperwork Reduction Act.

The information collection requirements placed on the public include unique Agency procurement requirements, which allow the Agency to: 1) determine if an offeror either has or can obtain the ability to competently manage development assistance programs utilizing public funds; 2) administer public funds in a prudent manner.

The most frequently used form is the Contractor Employee Biographical Data Sheet, AID Form 1420-17 (available at http://www.usaid.gov/forms), which offerors and contractors complete for employees and consultants whose salaries are reimbursable under the contract. The contracting officers use the information provided to determine if the individual meets the contract requirements and weather the salary is reasonable for the work to be performed. Other information collections are for post contract award purposes and are needed to properly administer the contract.
