Good morning Ms. Baucman,

Per the new yearly estimates, I know the ten-year average for Florida submissions is 24.5 per year. With the amount of nominations originating from non-consultant entities (as well as entirely staff-generated), I would feel comfortable estimating that Florida will have an average of 20 nominations per year. Generally, fourteen (14) are from non-consultants, four (4) are from consultants, and two (2) usually relate to a multiple-property submission cover. No new MPS covers are underway or planned at this time.

I hope that information is what you need – if not, please advise so I can get you the right numbers.
