Good day.

First, a little history about my case: I am a Filipino citizen who arrived in the united states of America on March 11, 2013 in Memphis International Airport using a K-1, Fiancee Visa to enter lawfully. My husband and I were united in Holy Matrimony on May 19, 2013, before the legal extent of the Visa expired, as required.

We applied for my adjustment of status using the Adjustment of Status, form I-485, and we included the rather large filing fee of \$1070. However, it was denied due to an incomplete Affidavit of Support, I-864, for us not being able to find a joint sponsor to meet the required gap my husband has below 125% of the manufactured poverty level.

Then, on March 22, 2014, I gave birth to our daughter in Jackson General Hospital of Jackson, TN.

I received an email just today, June 26, 2015, that contains a notice of a Request to Collect Information for the purposes of applying to **section 245 of the Immigration and Nationality act**. The letter was composed on June 22, 2015 by Laura Dawkins, Chief, Regulatory Coordination Division, Office of Policy and Strategy, U.S. Citizenship and Immigration Services, Department of Homeland Security. Here's the information that it seems to be requesting as pasted directly from the letter answered accordingly.

(1) Evaluate whether the proposed collection of information is necessary for the proper performance of the functions of the agency, including whether the information will have practical utility;

The collection of information for the I-485 all makes sense from an corporate, capitalist perspective, but not all of it, especially not the financial requirements for the I-864 that must accompany it, is relevant to more than an unnatural imposition born of the holders of such a flawed ideology.

(2) Evaluate the accuracy of the agency's estimate of the burden

of the proposed collection of information, including the validity of the methodology and assumptions used;

The agency seems to believe, against the majority opinion of its customers, that the collection of such information, and the inconsistencies within the methodology and assumptions used, is not an immense burden. Actually, it is and needlessly so.

(3) Enhance the quality, utility, and clarity of the information to be collected;

Acceptance and adherence to Universal and Common Law are the only valid requirements for any activity on earth, and statutory regulations are, as stated above, only the illegitimate creation of a corporate, capitalist ideology.

and (4) Minimize the burden of the collection of information on those who are to respond, including through the use of appropriate automated, electronic, mechanical, or other technological collection techniques or other forms of information technology (e.g., permitting electronic submission of responses).
