- 2. Regarding SNP Care Management Reporting Section 13.5 metric states "Initial HRAs not performed on new enrollees within 90 days before or after the effective date of refusal due to SNP unable to reach new enrollees". Shouldn't this wording state "effective date of enrollment vs. effective date of refusal"?

However we will have some good cause reviews for the members who are terminated for non-payment of premium effective 12/31/2015. Would these need to be included in the August 2016 reporting period?
