This credit applies to federal and some state or local governments.

☐ Certification of Noncompetitive Eligibility

Can only send if it is less than 3 years from your COS date.

☐ Teaching Certification of Volunteer Service

Can only send if your primary assignment was classroom teaching of host country national children, and you served for at least 18 months, training time included.

☐ Description of Service

Can only provide a copy; cannot send an original DOS. If you COS'd within the last 90 days, you will need to wait for your original DOS to be sent to you from post. If you haven't received your DOS from post, contact them to ensure they have your correct address to mail/email it to you.
