The Core Performance Reporting Requirements are designed to accommodate existing data collection methodologies that are currently practiced by the Department of Housing and Urban Development (HUD) competitively-funded grant programs. HUD is in the development of providing grantees access to an online data collection and reporting portal that will enable grantees to have the flexibility of using their own information management systems to collect participant record-level data and capital investment project-level information according to unique circumstances and resource availability. Once HUD implements the online data collection portal, grantees will be able to annually upload participant and capital investment record-level data via extensible markup language (XML) format files or grantees may manually enter data directly into the portal.

In the first year of the new reporting approach, a one-year pilot will be conducted of limited scope to ensure feasibility, effectiveness, and efficiency for HUD grantees and other stakeholders. The pilot will employ the use of the online data collection and reporting portal and will test the applicability and feasibility of the new approach and the data elements reported. HUD will provide grantees with technical assistance to facilitate and improve the reporting methodology. Each HUD program will only collect those data elements which are applicable to its program and grantees. Hence, the annual XML upload will comprise largely of data grantees already regularly collect. During and upon conclusion of the pilot, all facets of the new approach including methodology and data collected will be re-evaluated and may be revised before further implementation.
