Dear Ms. Williams:

Telecommunications for the Deaf and Hard of Hearing, Inc., National Association of the Deaf, Cerebral Palsy and Deaf Organization, Deaf Seniors of America, Hearing Loss Association of America, Association of Late Deafened Adults, and American Association of the DeafBlind (collectively, “Consumer Groups”), respectfully support extension of the Commission’s currently approved information collection requirements relating to closed captioning user interfaces of digital apparatus and navigation devices described in the above-referenced Information Collection notice. *See* 81 Fed. Reg. 22,266 (April 15, 2016).

The Commission’s information collections are a critical part of its overall efforts to effectuate Congress’s intent to recognize the civil right of people who are deaf or hard of hearing to access video programming on equal terms in the Twenty-First Century Communications and Video Accessibility Act (“CVAA”) and other legislation. While we are actively engaged with the Commission on the details of these collections and other aspects of its closed captioning rules, we believe in general that the collections are consistent with the spirit and letter of the Paperwork
