Dividing a street address into multiple fields has no practical utility, does not increase the quality of the information gathered, and increases the burden of the data collection on the form's users.

Requiring multiple signatures only leads to confusion. It does not enhance the utility of the information gather, it does not enhance the quality of the information gathered, and it increases the burden on the form users.

Requiring multiple statements and forms from attorneys is not only a burden, but also impinges on the right to be represented. And, it also represents an utterly unnecessary waste of paper. In this case over two pages worth. We note that real courts do not require special forms for an attorney to make an appearance. Neither should the agency.
