- > greatest need. The Revolving Fund Program helps qualified non-profits

- > create a revolving loan fund that can provide financing for the
- > extension and improvement of water and waste disposal systems in rural
- > areas. Entities eligible for the revolving loan fund will be the same
- > entities eligible to obtain a loan, loan guarantee, or grant from RUS
