Wheat flour (except flour mixes), made in flour mills	Checklist A, Group 01: 001-017	This category includes bakers' and institutional white flour, family white flour, and wheat flour other than white, including (but not limited to): whole wheat flour, durum flour, semolina flour, bulgur flour, and farina flour. This category does not include flour mixes, which are included in product category code 31121104
Wheat mill products except flour	Checklist A, Group 01: 018-025	This category includes non-flour wheat mill products such as mill feed, middlings, red dog, wheat germ, shorts, and wheat bran.
Corn mill products	Checklist B, Group 01: 001-009	This category includes all corn mill products for either human or animal consumption, including corn flour, cornmeal, hominy, corn grits and flakes, and other corn byproducts.
Prepared flour mixes, including refrigerated and frozen doughs and batters, made in flour mills	Checklist B, Group 01: 010-034	This category includes flour mixes and refrigerated or frozen doughs and batters that were manufactured in flour mills. Products in this category include: pancake and waffle mix, cake mix, biscuit mix, bread mix, roll mix, cookie mix, piecrust mix, doughnut mix, sweet yeast mix goods, refrigerated or frozen cookie dough, biscuit batter, bread, rolls, pasta dough, pizza dough, coffeecake dough, and pancake batter.
Other grain mill products	Checklist B, Group 01: 035-041	This category includes all other grain mill products, such as rye flour, barley flour, buckwheat flour, oat flour, fruit flour, and other types of non-wheat flours or mill feed.
Other (including secondary and/or misc. receipts)		Any secondary products and/or miscellaneous receipts.
