The use of myE-Verify allow employees the ability to see the information that is being used to confirm or deny their work eligibility. By allowing employees direct access to view this information, myE-Verify is promoting a transparent evaluation process. Additionally, myE- Verify provides an employee with the opportunity to recognize and correct - (MANIPULATE), a mistake in the records that E-Verify uses to determine eligibility before an employee is erroneously denied immediate work authorization. This ability to locate and correct inaccuracies before an employee is mistakenly denied creates a more efficient and proactive system of assessing employee work eligibility. This actually completely defeats the intent of E-Verify, so I strongly disagree with this stance and feel it is only an attempt to scam the system. NO extension to allow entry should occur if contrary to President.
