Subject: Comment on SSS Draft Guidelines

The published draft guidelines for the U.S. Department of Education's Student Support Services grant program state that all content must be double-spaced, including tables, charts, and headings. Last week, however, Maureen Hoyler, Executive Vice President of the Council on Opportunity in Education, indicated in a public forum that in conversations with ED officials she had determined that this requirement would not be enforced, except for single-spaced narrative text placed in a box. When contacted about this conflicting information, ED personnel either have not responded or have indicated that no decision has yet been made.

Final guidelines need to clarify the requirement. As Mid-South Community College prepares its proposal, we would prefer to be able to use single-spacing in true tables, charts, and section headings so that we can provide more detail in responding to required criteria. If, however, the language about double-spacing stays in place, we request that the Department of Education issue a clarification indicating that non-conforming proposals, that is, those containing single-spaced tables, not be read. The application process cannot be a fair one if some institutions double-space and others single-space tables because the latter will have more room for details in the proposal narrative. Our experiments with both types of formatting indicate that proposals using single-spacing for tables would gain up to 10 pages for additional narrative content.

Good Day

We are in the process of preparing our TRIO Student Support Services project and just have this one major concern about the year's guidelines. While we appreciate the reduction in the number of pages, we are concerned that the requirement to double-space tables, charts and headings will limit our ability to explain our situation, project goals, and evaluation plans.

- Double-spacing which results in tables and charts running onto additional pages makes it more difficult to read and compare data.
- Because tables and charts have rows of numbers with fewer words, the result of double-spacing will be to add to the white space on the pages.
- · Using excessive page space for tables and charts leaves much less room for the narrative that helps make sense of the data and explains our project.

There seems to be some confusion about this requirement. The Council for Opportunity in Education says that single-spacing for tables and charts is acceptable for SSS proposals, but we have not heard a final decision from the U.S. Department of Education.

We at Jackson Community College hope that you reconsider the double-spaced requirement for tables, charts and headings and allow for single-spacing.

Draft guidelines instruct the applicant to double-space all proposal content, including tables, charts and headings while the Council for Opportunity in Education advised member organizations that tables can be single-spaced.

A. Our clear preference would be to have final guidelines permit single-spacing in tables, charts, and headings for a requirement to single-space all tables, charts and graphs would severely limit the content of the application.

IMPORTANT CONSIDERATION:

B. The Dept. of Education must issue a clarification to all potential applicants indicating any applications submitted with single-spaced charts and graphs will not be returned unread. If this does not occur, those applicants who adhere to the guidelines and double space everything will be at a severe disadvantage because of the limited amount of information included in the proposal.

To whom it may concern,

I'm writing to comment on the draft SSS grant application for fiscal year 2009. I suggest that the application be revised as follows:

- 1) Section IV: Application & Submission Information, 2. Content & Form of Application Submission reads:
 - a.. Double space (no more than three lines per vertical inch) all text in the application narrative, including titles, headings,

footnotes, quotations, references, captions and all text in charts, tables, and graphs.

Comment: The requirement to double space all text within the document is reasonable in regards to the narrative with the exception of footnotes and all text in charts, tables, & graphs. To require that all footnotes & charts/tables/graphs be double spaced is unreasonable because:

- · It is inconsistent w/normal formatting for documents in which text in graphs, tables, charts, & footnotes is single spaced. To require double spacing of footnotes & tables will make the narrative harder to read for reviewers. In a practical sense, double spacing tables will result in long, unreadable tables that may span multiple pages, making it quite difficult for readers to read, understand, & compare data within and between tables.
- 2) In the SSS Profile, the standardized program objectives include a persistence rate objective that reads:
- 1. Persistence Rate: ____% of all participants served by the SSS project will persist from one academic year to the beginning of the next academic year or graduate and/or transfer from a 2-year to a 4-year institution during the academic year.

Comment: Allowing only 2-year institutions to count transfer from a 2-year to a 4-year institution toward persistence while not allowing 4-year institutions to count transfer from a 4-year to a 4-year institution toward persistence is unreasonable. In many instances, students participating in a SSS program at a 4-year institution transfer to another 4-year institution b/c it fits their major/career needs better, has more appropriate academic offerings, or is more affordable. As the objective currently reads, the impact of that student's participation in SSS at her/his original 4-year institution is lost once the student transfers to another 4-year institution when, often, participation in SSS at one 4-year institution positively affects the student's persistence and graduation at another 4-year institution. This persistence could easily be tracked by the original SSS program by querying student data using the National Student Clearinghouse. Persistence should include continuation at ANY 4-year institution, not just the institution at which the student's original SSS project is located. Should the student participate in another SSS project at their transfer 4-year institution, the SSS project at their original institution would no longer track and report on their persistence.
