The Food and Nutrition Service (FNS) of the United States Department of Agriculture (USDA) is requesting approval to collect sample frame information under Approved Generic OMB Clearance No. 0584-0613 Special Nutrition Programs Quick Response Surveys, expiration date 02/28/2021.

This memorandum is to acquire clearance to collect work-related contact information for local administrators and other characteristics of local entities of the Special Nutrition Programs (SNPs) from State agency SNP administrators. This information will serve as SNP sample frames needed to conduct SNP Quick Response Surveys (QRS). The following information is provided for your review:

 - Fresh Fruit and Vegetable Program (FFVP)
 - Food Distribution Program on Indian Reservations (FDPIR)
 - Commodity Supplemental Food Program (CSFP)

4. Number of Respondents & Research Activities:

6. Total Burden Hours on Public:

Total burden is presented in the enclosed burden table entitled *Appendix A: Estimated Burden for Data Collection and Nonresponse for SNP QRS Sample Frames*. The total burden hours that will be used for sample frame collection in 2018 are: 533.

7. Project Purpose, Methodology, and Research Design:

Background

The SNP QRS Sample Frame collection will allow FNS to quickly collect work-related contact information for local administrators and other characteristics of local entities of the SNPs from State agency administrators of the nine programs listed under #3 of this memo. This local information will be collected from State agency (SA) SNP administrators and will serve as SNP sample frames (i.e., the universe of respondents for any entity) to support the SNP Quick Response Surveys (QRSs) and other FNS studies. This is the second collection under the SNP QRS umbrella clearance (OMB #0584-0613 Special Nutrition Programs Quick Response Surveys; Expiration date 2/28/21).

FNS conducts multiple complex studies on broad topics about each SNP. Studies involving the same SNP may burden State and local administrators multiple times per year for the same work-related contact information and other characteristics of local entities. Although the sample frame information collected is for the stated purpose of conducting these short, quick-turnaround research studies, this information can also be used for other FNS-sponsored studies of the same programs, thereby alleviating burden to State agencies. Compiling a comprehensive list of State and local-level program administrators can be time consuming and prolong completion of studies. Similarly, data collection and follow-up efforts may be prolonged if the most up-to-date information is not used to contact respondents. Compilation of the SNP QRS sample frames will provide a more expedient mechanism for obtaining and maintaining respondent contact and characteristic information necessary for conducting studies.

Purpose

The SNP QRS sample frames will provide FNS and the study team with sample frames to use in conducting the SNP QRS and other studies with the same respondent groups. The type of respondent contact information collected from State agencies about the local entities under their purview will generally include: name, position title, work telephone number, work address, and work email, at a minimum, but may include other characteristics related to the

program entity (e.g., region, urbanicity, caseload) that will vary by SNP and provide variables to support sampling stratification.

Methodology/Research Design

Assembly of SNP sampling frames with updated LA contact information and other necessary frame-level characteristics will be accomplished through an email request to SA administrators. As it is expected that most SAs will have this information readily available, the information can be submitted electronically in a spreadsheet or other electronic format in which the information is already stored (e.g., document, database file). In this first year of sample frame collection, SA administrators will be provided with a template electronic spreadsheet that can be used to populate contact and other information for LAs (see Figure 1 and Appendix C for an example of the spreadsheet template for SNP local agency contact information; see Appendix B for a template of the email that would accompany this spreadsheet). In subsequent years, SAs will be provided with a prepopulated spreadsheet that they will be requested to update. Contact lists obtained from each SNP's electronic spreadsheet or other files will be consolidated to create sample frames for each respective SNP.

Design/Sampling Procedures

Sample frames will represent a census of all agencies; therefore, no sampling of these entities will take place.

Recruitment and Consent

For this sample frame collection, FNS will liaise with FNS Regional offices to collect and verify contact information for its State program offices. SA administrators will be contacted by the study team via email with a request that they complete, update, and/or confirm the LA contact information contained in an electronic spreadsheet for their program. SA administrators will also be given the option to submit their current LA contact lists in the format available. The email will explain that either approach is acceptable. Follow-up using email may also be used to remind respondents of the request and encourage their response (see Appendix B for the reminder email that will be sent to SA administrators). All initial contact and follow-up procedures will be the same for each type of SA respondent.

While this information collection is voluntary, in most cases, FNS expects that collection of LA contact information from SAs will be a census.

The SNP SA administrators providing contact information for the sample frames will not receive an incentive payment or gift.

8. Confidentiality:

All contact information gathered from SNP State administrators pertaining to local-level SNP officials is for research purposes only and will be kept private to the full extent allowed by law. State administrators providing this information will be assured that respondent contact information (name, work phone number, and work email) will remain private and will only be used for the purposes of contacting local SNP staff to participate in a QRS or other FNS study.

FNS published a system of record notice (SORN) titled FNS-8 USDA/FNS Studies and Reports in the *Federal Register* on April 25, 1991, volume 56, pages 19078-19080, that discusses the terms of protections that will be provided to respondents. FNS and the study team will comply with the requirements of the Privacy Act of 1974.

9. Federal Costs: \$271,278

We estimate that Federal employees will spend approximately 200 hours overseeing the compilation of the sample frame information in 2018. Using the hourly wage rate of \$45.59 for a GS-12, step 6 Federal employee from the 2018 Washington, DC locality pay table, the estimated 2018 costs equal \$9,118. Contractor costs associated with compiling sample frame information will total \$262,160 to the Federal government this year. When combining the Federal employee and contractor costs, the total annual cost to the Federal government for this collection is estimated at \$271,278.
