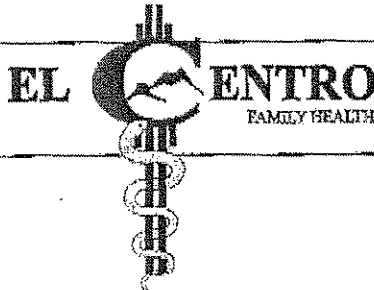
processes.


