Please consider this email our response to the new proposed collection of information.

The requirement to provide certified actuarial report for renewal applicants seems to be unduly burdensome. Further, the cost to have one performed yearly would be expensive. We have fewer than 10 active claimants on our books and the total liability falls well within our self-insured retentions. We suggest that you remove this requirement for those companies that do not have outstanding/future excessive BLBA exposures.
