Thank you for your comment. I am responding on behalf of Ms. Pollard and Mr. Jones.

HUD is one of several Federal agencies that collect information under the Home Mortgage Disclosure Act (HMDA) and the information collection requirements are identical across these agencies. The Federal Financial Institutions Examination Council is an umbrella group and one of its roles is to administer HMDA data collection. As such, FFIEC offers much information on HMDA reporting including the forms referenced in the HUD Notice of Proposed Information Collection. Below are three websites you may find helpful.
