We are respectfully requesting to submit additional comments for the above forms as follows:

- (1) Electronic/Digital Signature on all Proposed Forms will need to specify or define the style and format that USDOL will accept
 - a. Will USDOL approve/accept printed signature? USDOL currently accepts and approves printed signature for NM WOTC/USDOL format and style. State of NM prefers printed signature.
 - b. Applicable to: Proposed form: ETA-790 Agricultural Clearance Order, page 8, #5, Signature (or digital signature)
 - c. Applicable to: Proposed form ETA-9142A – Final Determination H2A Temporary labor certification approval, #11 (electronic signature)

- (2) Matching format/styling to print forms as a hard copy report output for USDOL forms
 - a. Does the format/style matching need to be exact duplicate of the USDOL forms?

State of NM currently designing and conceptualizing custom development of the USDOL forms as part of ongoing improvements to FLC. The goal is to provide electronic capabilities to the forms so that the information from the forms is an electronic input source for Salesforce CRM case management system while ensuring we align to what USDOL approves or accepts on style and format.
