- 1. Since we have to report Meal Times (Breakfast, Lunch, Snack Time AM, Snack PM Dinner/Supper) why do we also then have to report "Meal Type (B)reakfast, (L)unch, (S)upper, (M)orning Snack, (A)fternoon snack" by listing the letter code. This is the same information we are reporting under the Meal time columns. This is redundant information.
- 2. What is the use of Columns AA, AB, AC, AD, AE, AF, AG, AH, AI, AJ, AK, AL? Being the one that does the uploads, I've never used these columns and I'm not sure what they are for. Are these columns for Summer Tech Support Only?
- 3. Why can't the uploads be sent beginning of the week or end of the week as opposed to the middle of the week? I always have several more changes on the Thursday after the upload. How long does it take for the uploads to actually be visible on the site locator? Next day, beginning of the following week? I had several comments from sponsors that said they did not see their information regarding their sites until 2-3 weeks from the date their sites were approved and I got the upload sent.
- 4. If only open sites are uploaded to the site locator map, why are we required to put other types of sites on the upload list when they are not actually uploaded to the Site Finder?
