### Proposed Revisions to Transmittal #2

Connecticut suggests that Section 1 Case Processing Actions: Box 10 be changed to remove any reference to tax refund offset or federal collection and enforcement. Connecticut proposes that box 10 be changed from/to:

- This proposed change eliminates the creation of federal tax information (FTI) and the subsequent need to safeguard. States are required to notify other states of any “direct payments” or receipts, including but not limited to tax return offsets, so that the other state IV-D agency can properly credit the respective system.
- This proposal also adds space for IV-D agencies to insert the full amount of the “direct payments” thereby notifying the other agency of the proper credit.
- The addition of “received” and “disbursed” date fields helps communicate additional details so that the proper and on-time credit is given.
