## Integrated Health

### 18 agencies

are partnering with health systems and/or hospitals in efforts to reduce hospital admissions and improve health outcomes for vulnerable populations.

### 72%

recipients of mental health services showed a reduction in symptoms or increase in functioning, as measured by Global Assessment of Functioning or similar scale.



## Immigration and Refugee Services

### 16,000

refugees were assigned for resettlement.

### 74%

of employable refugee adults were employed during resettlement period.

### 90%

of cases for deferred action, residence and citizenship petitions were successful.



## Affordable Housing

Catholic Charities owns/operates **35,000 units** of permanent housing.

Catholic Charities operates more permanent supportive housing beds (6,000) and rapid re-housing beds (5,000) for formerly homeless individuals than other national nonprofits that provide homeless assistance services.

Compared to other senior housing in the same communities, Catholic Charities senior housing is newer, in better condition, and more fully occupied.

### 56%

of clients in emergency shelter or transitional housing were discharged into permanent housing.

### 81%

remained permanently housed 6 months after discharge.



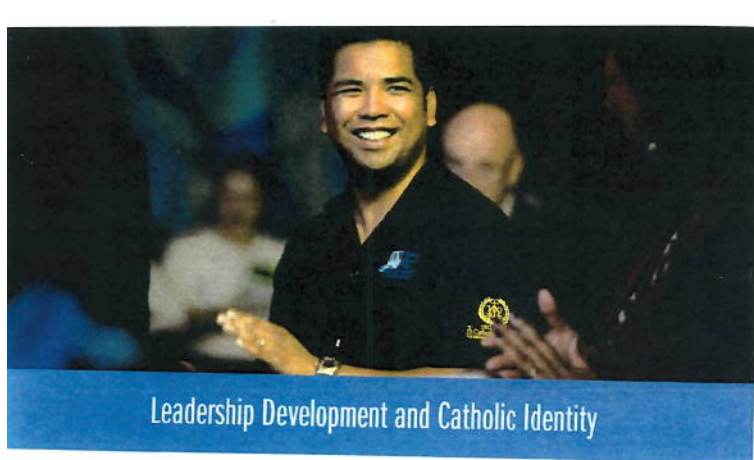
## Disaster Services

2017 will be remembered for the hurricanes that ripped through Texas, Louisiana, Florida, Puerto Rico and the U.S. Virgin Islands. Catholic Charities agencies responded immediately with holistic care and direct assistance for survivors. Catholic Charities helps people before, during and after every disaster to move toward full recovery.

### \$38.6 million

distributed to agencies affected by the hurricanes.





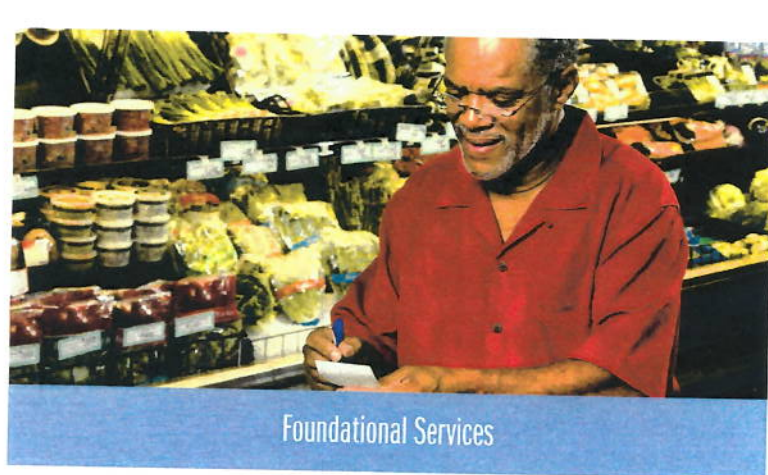
## Leadership Development and Catholic Identity

**100%**

expansion of leadership development programming.

staff attended Partners in Excellence leadership training events held throughout the country.



## Foundational Services

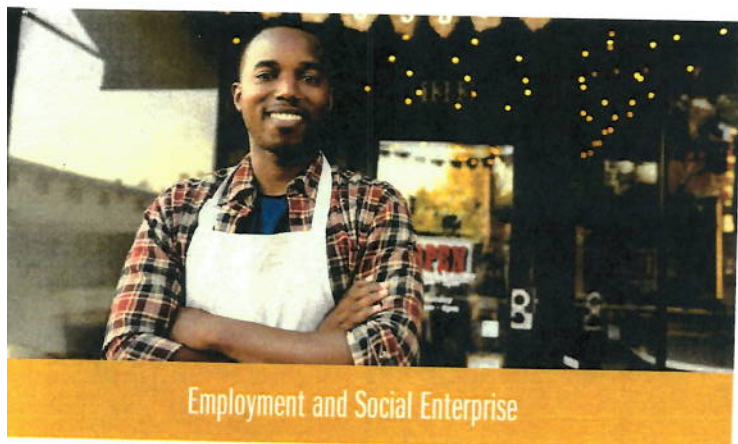
Catholic Charities agencies served over **27 million** prepared meals. An additional **4.7 million** clients facing food insecurity were served through food banks and food pantries.

**>75%**

of clients in self-sufficiency programs reached targets for food, housing, and access to services.

**84%**

of clients receiving rental assistance remained housed at 6-month follow-up.



## Employment and Social Enterprise

**65,000 clients**

involved in employment programs.

**41**

active social enterprises employed **900 clients**.

**63%**

of clients in employment programs are employed at agency target wages. This is 38% higher than the national minimum wage.

Industry-recognized certifications include Construction, Food Safety, Forklift Operation, Culinary Arts, Sherwin Williams Painter, Landscaping/Horticulture, Carpentry, Automotive Tech, Certified Nurse Assistant, Geriatric Home Aide, Lead Abatement.



## Advocacy and Social Policy

Catholic Charities USA monitors over 200 federal programs impacting millions of people who are poor and vulnerable. Guided by our Catholic Social Teaching CCUSA weighed in on the most critical issues including:

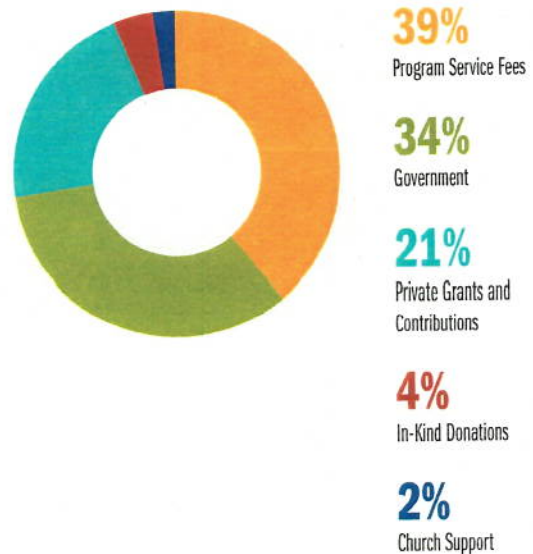

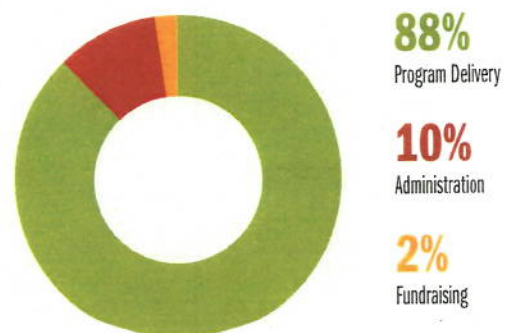
