SUBJECT: Results of the 2019 Multi-Family Housing Annual Fair Housing
Occupancy Report

We are pleased to present the 2019 Rural Development Multi-Family Housing (MFH) Annual Occupancy Report, which includes both Section 515 Rural Rental Housing (RRH) and Section 514 Farm Labor Housing (FLH) properties. These results are based on September 2019 data from the Multi-Family Integrated System (MFIS) database.

This report presents data from the past three years, comparing information from years 2017 to 2019. Attachment A is a summary of report results. Highlights of this year's data include:

- The total number of rental properties has decreased by (1.63) percent since last year or a decrease of 214 Section 515 properties and a decrease of 10 FLH properties. The number of rental units in the MFH portfolio has decreased by 1.04 percent. Overall, we saw a reduction of 224 properties in the past year, representing 4,375 apartment units.
- The current population shows a slight decline in the White population from 65.54 percent to 65.31 percent. The breakdown now consists of:
 - White, Non-Hispanic households: 65.31 percent
 - Black Non-Hispanic households: 19.95 percent
 - Hispanic households: 11.62 percent
 - Asian, Pacific Islander households: 0.72 percent
 - American Indian/Alaskan Native households: 1.60 percent
 - Multi-Racial households: 0.80 percent
- There was a slight increase in very-low income households, which represent 92.06 percent of all households. Low-income households represent 6.87 percent of the total.

- Average household incomes are up to \$14,014 from \$13,552 (a 3.41 percent increase); the average income of Rental Assistance (RA) households increased to \$11,557 from \$11,176 (a 3.41 percent increase).
- Female-headed households continue to represent the majority of households (71.5 percent).
- There was no appreciable change in the percentage of elderly/disabled households versus non-elderly households.
- The disabled population continues to increase within the elderly/disabled households.

In comparing the Section 515 RRH portfolio with the Section 514 FLH portfolio, it is interesting to note:

- FLH members per household are about twice the size of the average household in the portfolio. Average farm labor income is more than one and half times that of the average RRH portfolio household (\$25,982 vs \$13,551). Farm labor income for RA households, \$18,700 is significantly higher than the average RA income for the RRH portfolio, \$11,285.
- Elderly/disabled households make up **65.2** percent of the RRH portfolio, but only **23.6** percent of the FLH households.
- RA households make up 69.3 percent of the RRH portfolio and 68.1 percent of the FLH households. RRH showed a slight increase and FLH showed a slight decrease in RA households compared to last year.
- White households constitute 67.6 percent of the RRH portfolio, while minorities constitute 93.9 percent of the FLH households.

The report also shows about the same percentage of households using RA compared to last year. Rent overburdened households (those paying more than 30 percent of their income towards rent) continue to decline, but this trend is primarily due to the decrease in units available.
